### Acceptable Conditions for Which an Appeal May Be Granted

Acceptable Conditions	Examples of Acceptable Documentation
Serious illness or personal injury	Doctor's note, accident report, medical bills
Death of an <u>immediate</u> family member (parent, spouse, child, sibling, legal guardian)	Copy of death certificate
Undue hardship: examples include job loss, separation/divorce, loss of home, recall to military duty, previously undiagnosed learning disability, incarceration	Termination letter from former employer, separation/divorce papers, eviction notice, bankruptcy papers, discharge papers
Maximum Allowable Credits	

### Instructions for Completing Your Financial Aid Suspension Appeal

- Obtain all necessary documents in support of your Appeal (see acceptable examples in chart above).
- <u>Type</u> your Appeal statement briefly describing:
- past circumstances that affected your ability to make satisfactory academic progress,

### AND

• changes you have made/will make to enable you to handle your coursework more effectively in the future,

#### <u>OR</u>

- You may submit a copy of your academic Suspension Appeal and academic success plan, if applicable, in place of #2.
- Complete and sign this form.
- Attach and submit <u>all</u> required Appeal documents together at the One Stop Enrollment Center or <u>OneStop@berkshirecc.edu</u>

## **Notification of Appeal Decision**

You will be contacted by your BCC Student Email:

- If you need to schedule an appointment with the Director of Student Financial Services (or designee) to discuss the conditions of your reinstatement, or
- If your Financial Aid Appeal is otherwise incomplete.
- If your Financial Aid Appeal is granted/denied.



#### **Financial Aid Requirements and Information**

- Appealing a Financial Aid Suspension is a separate process from Appealing an academic Suspension. If you meet with the Director of Advising and/or the Student Standing Committee and you are allowed to re-enroll at BCC, you must still separately Appeal a Financial Aid Suspension, or be prepared to pay college charges out-of-pocket.
- BCC will not consider Appeals on the basis of pre-existing conditions or circumstances already cited in a previous Appeal.
- Students may submit no more than 2 Financial Aid Suspension Appeals at BCC. However, if your Appeal is denied, you may re-Appeal if/when you have rehabilitated your academic record to comply with federal Financial Aid standards.

#### I understand that:

- □ I am only allowed to take courses that are required to complete my Academic Program.
- □ If my Academic Advisor and I make changes to the Academic Plan that I submitted with my Appeal, I am required to submit a new Academic Plan to the One Stop Enrollment Center.
- □ I am required to notify the One Stop Enrollment Center if I make changes to my registration while I remain on Financial Aid Probation.
- □ I must complete all of my courses, without withdrawals, incompletes, or failures, while I remain on Financial Aid Probation.
- □ I must maintain a minimum 2.000 term GPA each semester that I remain on Financial Aid Probation.
- □ If I am thinking about withdrawing from a class, I must contact the One Stop Enrollment Center so that I understand the consequences.
- □ The Financial Aid Suspension Appeal Committee/Director of Student Financial Services may recommend that I begin/continue working with an Academic Advisor.
- □ The Financial Aid Suspension Appeal Committee/Director of Student Financial Services may recommend that I utilize Tutoring Services, TRIO, Success Coach and/or the Disability Resource Center.
- □ If I apply for a student loan while on Financial Aid Probation, I may be recommended to meet with BCC's Student Loan Coordinator for one-on-one loan counseling.

By signing below I understand that if my Appeal is approved, I will be required to meet all requirements listed above. I also understand that my Financial Aid funds will not be disbursed to my account if these requirements are not met and may result in the loss of future aid.
